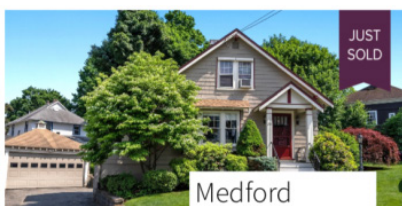

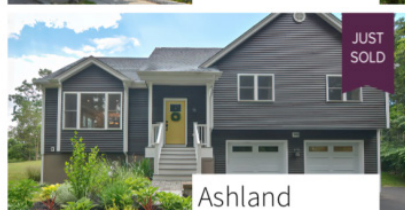

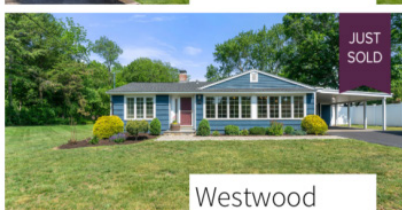

FINANCIAL RELIEF TO HOSPITALS AND COMMUNITY HEALTH CENTERS (H 4530)

House 148-1, Senate 39-0, approved and sent to Gov. Maura Healey \$234 million supplemental budget that would provide financial relief to hospitals and community health centers across the state.

The bill includes \$199 million in relief

for acute care hospitals, including \$122 million in targeted payments to facilities serving low-income patients and facing the greatest financial distress. Another \$77 million would be transferred to the Health Safety Net Trust Fund, which helps reimburse hospitals and health centers for care provided to uninsured residents. Community health centers would receive

\$35 million, including \$2.5 million directed to the Massachusetts League of Community Health Centers for initiatives such as shared services.

“Massachusetts has a healthcare ecosystem that is the envy of other states, and that doesn’t happen by accident,” said Senate President Karen Spilka (D-Ashland). “Supporting every resident is part of what it means to be a leader in healthcare access. This funding will help our hospitals and community health centers provide high-quality care in every region, and provide critical services to our veterans, seniors and municipalities.”

“This funding will help to ensure that financially strained hospitals and community health centers can continue to serve patients across Massachusetts,” said House

Speaker Ron Mariano (D-Quincy). “As broad fiscal uncertainty and actions taken by the Trump Administration continue to exacerbate the challenges that hospitals are already facing, this supplemental budget is the latest example of the work that we are doing here in Massachusetts to provide targeted support where it is needed most.”

“Our hospitals and community health centers continue to step up to care for those most in need despite being under enormous financial pressure,” said Sen. Cindy Friedman (D-Arlington), Senate Chair of the Committee on Health Care Financing. “New policies from the federal government will only exacerbate the strain on our health care infrastructure, so for Massachusetts to continue to be a leader in providing exceptional health care, we need to ensure that care is accessible, especially

to our most vulnerable populations. This supplemental budget provides necessary funding to help live up to this goal.”

Rep. Nick Boldyga (R-Southwick) cast the lone vote against the budget. “This \$250,000,000 bailout is due to the failed policies of the Democrats,” said Boldyga. “Once again they blamed President Trump but the reality is Democrats allowed ‘uninsured’ illegal aliens to flood our hospitals. Our healthcare system is now overwhelmed, bankrupt and broke.”

Somerville’s Charter Update: A Patchwork of Lost Opportunities

Somerville’s new city charter, fresh off Governor Maura Healey’s signature and bound for the November 4 ballot, promises tweaks like clearer budget processes, beefed-up City Council oversight, and exploratory nods to ranked-choice voting and public

campaign financing.


On paper, it’s a glow-up from the dusty 1899 version—ditching archaic Latin and mandating decennial reviews sounds progressive enough. But dig deeper, and it’s a glaring shortcoming: decades of half-measures since 1871, with fizzled 2008

reviews and token changes like a 2018 name swap from “Board of Aldermen” to “City Council.”

This isn’t bold reform; it’s reactive housekeeping after years of neglect, leaving core power imbalances intact in a mayor-centric system that’s stifled real accountability. We

could’ve modernized this ages ago with visionary updates on ethics, fiscal transparency, and electoral innovation, but instead, we’re left with a ballot box Band-Aid that feels like settling for crumbs.

The Hidden Costs: Why “Woke” Ideology Has Undermined Modern Society

A core harm lies in its clampdown on honest exchange. At universities, guest lecturers challenging mainstream takes on issues like identity or ethnicity often face protests or cancellations, evident in events at places like Yale and UC Berkeley. This environment breeds fear, where students and

faculty self-censor to dodge backlash, ultimately weakening the pursuit of knowledge. Research from the Foundation for Individual Rights and Expression shows a sharp rise in such disruptions, correlating with declining enrollment in humanities and a broader distrust in higher education.

The City of Somerville is seeking one new volunteer member to join the Somerville Municipal Scholarship Committee.

What is the Municipal Scholarship Committee?

The mission of the committee is to award scholarships to high school

graduates to use toward their higher education expenses. The funding for the scholarships comes from voluntary contributions made by Somerville taxpayers. Scholarship Committee members develop a meeting schedule, review redacted scholarship applications, set criteria for scholarship awards, and make award recommendations.

Who Can Join?

All Somerville residents are invited to apply. Desired qualifications include:

Willingness to spend time individually evaluating and reviewing anonymous scholarship applications based on materials that will be supplied to

you.

Openness to learning a numerical rating system and submitting written notes to keep in files to document process and decisions that were made.

Ability to work with other reviewers in a team environment, in-person and/or remotely.

Openness in revealing any conflict of interest with potential scholarship applicants.

Understanding the need for fairness, objectivity and nondiscrimination within the scholarship selection process.

Ability to recognize a need to modify scholarship criteria and other aspects of the award process, if

required, and make recommendations for change.

Ability to focus on the specific Committee selection criteria in determining the award winners.

Using Committee selection criteria, make recommendations on recipients for scholarship for final approval by the mayor.

What is the Time Commitment?

The Municipal Scholarship Committee meets once a month during the day or evening from October through April or May. Additional time to meet during the application-to-award process, January through May/June, is required.

What is the Appointment Process?

Members are appointed by the Mayor.

\$9 MILLION IN LITERACY LAUNCH GRANTS

Gov. Healey announced that the state is awarding over \$9 million in Partnership for Reading Success – Massachusetts (PRISM) continuation grants to 15 school districts as part of her Literacy Launch initiative. These grants enable districts to implement high-quality, evidence-based reading instruction

through literacy materials, technical support, coaching and professional development.

“Literacy Launch is a historic investment in early literacy for our students,” said Healey. “These continuation grants represent our commitment to make sure all of our students can read and read well.”

“Ensuring every student has access to high-quality, evidence-based instruction in early literacy is essential for Massachusetts families,” said Lt. Gov. Kim Driscoll. “Through PRISM continuation grants, we are providing children the support they need to excel and thrive in the future.”

“Culturally and linguistically sustaining practices and evidence-based early literacy are fundamental to achieving excellence and equity in education,” said Secretary of Education Dr. Patrick Tutwiler. “The PRISM 1 program will continue to help districts improve literacy programming, ensuring that our youngest learners build a strong literacy foundation that

will support their success throughout their education.”

EXPAND NICKY’S LAW (S 165)

The Senate approved and sent to the House legislation that would expand current law by including day habilitation programs contracted by MassHealth in the existing statewide registry that prevents individuals with substantiated abuse allegations from being hired in care positions.

Supporters said the bill

would expand “Nicky’s Law” which was proposed by Sen. Mike Moore (D-Millbury) and signed into law in 2020 by former Gov. Baker. Nicky’s Law, established a registry of care providers found guilty of registrable abuse after Nicky Chan, a young man with a disability, was abused by an employee at a day program he attended.

“Because no registry existed, this employee, and the witness who never reported the abuse, were able to find employment at another agency,” said Moore. “This new bill will ensure no individual with a disability will be subject to abuse while receiving services from a MassHealth day habilitation program.”

“Placing your trust in a caretaker to ensure the safety and wellbeing of a child, parent, family member, or loved one with a disability is hard,”

continued Moore. “When that trust is violated, it can feel like the ultimate betrayal of not only the caretaker who did it, but also the system that allowed it to happen. This legislation represents another step toward making sure Nicky’s story does not happen to anyone else.”

“When Nicky’s Law was first passed, it was about creating protections and accountability for some of our most

vulnerable residents,” said Sen. Robyn Kennedy (D-Worcester), Senate Chair of the Committee on Children, Families and Persons with Disabilities. “By expanding these safeguards to include day habilitation programs, we are making sure that no one falls through the cracks.”

FENTANYL TEST STRIPS (S 1057)

The Senate approved and sent to the House a bill that would exclude fentanyl test strips and fentanyl drug testing equipment from the definition of drug paraphernalia.

It also includes a Good Samaritan Law that would provide that anyone who, in good faith, provides, administers or utilizes fentanyl test strips or fentanyl drug testing equipment

shall not be subject to any criminal or civil liability or any professional disciplinary action.

The legislation expands a 2024 law that provided criminal and civil liability protections for those in the harm reduction community who provide or use fentanyl test strips in good faith. The bill would expand the liability protections beyond those just in the harm reduction community and ensure police

officers and others who seek to distribute the tests or others acting in good faith are afforded legal protection.

Supporters said that under current law, selling or distributing these items could be a crime. As a result, police departments and others who are interested in distributing fentanyl test strips are concerned that doing so would subject them to criminal or civil liability. They noted that

Massachusetts already has a similar Good Samaritan law to shield people from liability anyone who administers naloxone, an opioid antagonist which is used as an emergency treatment used for the complete or partial reversal of an opioid overdose.

“Fentanyl test strips are inexpensive, easy to use, and, most importantly, they are an evidence-based tool that saves lives,” said Senate Majority Leader Cindy

Creem (D-Newton), the sponsor of the measure. “By making them widely available, Massachusetts can give people one more way to prevent overdoses and protect families from tragedy.”

MOVE 2026 PRIMARY ELECTION DATE TO SEPTEMBER 1 (H 4531)

By Bob Katzen

The House and Senate approved and sent to Gov. Healey legislation setting next year’s state primary election date for Tuesday, September 1, 2026.

Supporters said this action is a standard step in the lead up to an election year to ensure the primary

date complies with state and federal requirements. It ensures that local clerks are given necessary time to send and process vote-by-mail ballots for Massachusetts residents, and gives election officials the ability to meet a required federal timeline for sending ballots to military servicemembers and citizens overseas.

“Given the calendar, holidays, requirements that we allow time for overseas ballots, including for members of the military, and to allow time for the printing of ballots, setting a date can sometimes be difficult,” said Sen. John Keenan (D-Quincy), Senate Chair of the Committee on Election Laws. “This legislation will put the commonwealth in position to meet

these obligations and run another smooth, safe and secure primary election on September 1, 2026. Now, more than ever, our democratic process must remain steadfast in the face of unprecedented federal uncertainty.”

“It is always important to be proactive in setting the primary election to ensure we select a date that

encourages voter participation,” said Senate President Karen Spilka (D-Ashland). “I am glad that we settled the date a year in advance, giving voters ample time for public awareness and giving our hard-working election administrators ample time to prepare.”

CAR RENTALS (S 2367)

Senate 39-0, approved and sent to the House a bill that supporters said would align the Bay State with the majority of other states by updating car rental insurance requirements to maintain liability coverage on a secondary basis, making rental companies responsible only if the renter is uninsured or underinsured.

If a lessee or operator of a leased vehicle already has a valid liability policy or equivalent financial security meeting the state minimum requirements, the lessor’s coverage obligation is considered satisfied.

Supporters said that by shifting primary liability to the renter’s personal auto insurance, the legislation helps make car rentals more affordable and accessible for Massachusetts residents, reducing

costs while maintaining necessary protections.

“When friends visited me on Cape Cod this summer, they were stunned at just how expensive it was to rent even a small sedan for the weekend,” said sponsor Sen. Julian Cyr (D-Truro). “And they’re not wrong — rental car prices in Massachusetts are higher than almost anywhere else in the country, in part because we’ve kept

an outdated insurance requirement on the books. We’re one of the only states where rental companies, not your own insurance, are required to carry primary coverage, and the cost of that policy gets passed right along to consumers.

Cyr continued, “By aligning Massachusetts with the rest of the country, we’re helping lower rental car prices for families, travelers and anyone who needs to rent a car in

a pinch. I’m proud the Senate has taken this step to make life just a little more affordable for our residents and visitors.”

(A “Yes” vote is for the bill.)

Fire Department to Conduct Annual Hydrant Inspections September 15-27



Inspection program keeps hydrants citywide ready in case of fire; Temporary water discoloration may occur, but water is safe to drink

SOMERVILLE- The Somerville Fire Department will begin the annual inspection and flushing of all fire hy-

drants citywide on Monday, September 15, 2025, concluding on or around Saturday, September 27, 2025. This annual maintenance program helps keep our community safe by helping to ensure hydrants will work properly when needed to put out a fire.

This inspection and testing program will take approximately two weeks to complete. Work will be conducted Monday through Saturday from 9 a.m. until 4 p.m. and if necessary, in the evening, from 6:15 p.m. until 8:15 p.m. Firefighters will check the mechanical opera-

tion of each hydrant, as well as briefly flush water from the hydrants. Feel free to thank our brave fire fighters for their year-round service when you see them out for this effort.

In most cases, community members will not notice any changes to their water service.

However, in some cases you may experience a temporary, slight drop in water pressure and/or discolored water: Though the water may be discolored, it is safe to drink. If discoloration occurs, you can open the cold tap nearest

the water meter—such as a basement sink or a ground-floor sink—to full flow until the water runs clear. In some situations, this may take 5 to 10 minutes. Until the water runs clear, it is advisable to avoid washing laundry, especially white fabrics. If you happen to wash laundry while the water is discolored, don't dry those items. If any rust stains appear on wet laundry, those items should not be dried, and you can call 311 (617-666-3311) for a free bottle of rust remover.

The Water Department also conducts additional water main flushing and maintenance year-round. Visit somervillema.gov/hydrantflushing to see hydrant flushing schedules by street. The schedules are typically updated weekly.

Hydrant inspection and flushing schedules are subject to change based on weather and other factors.

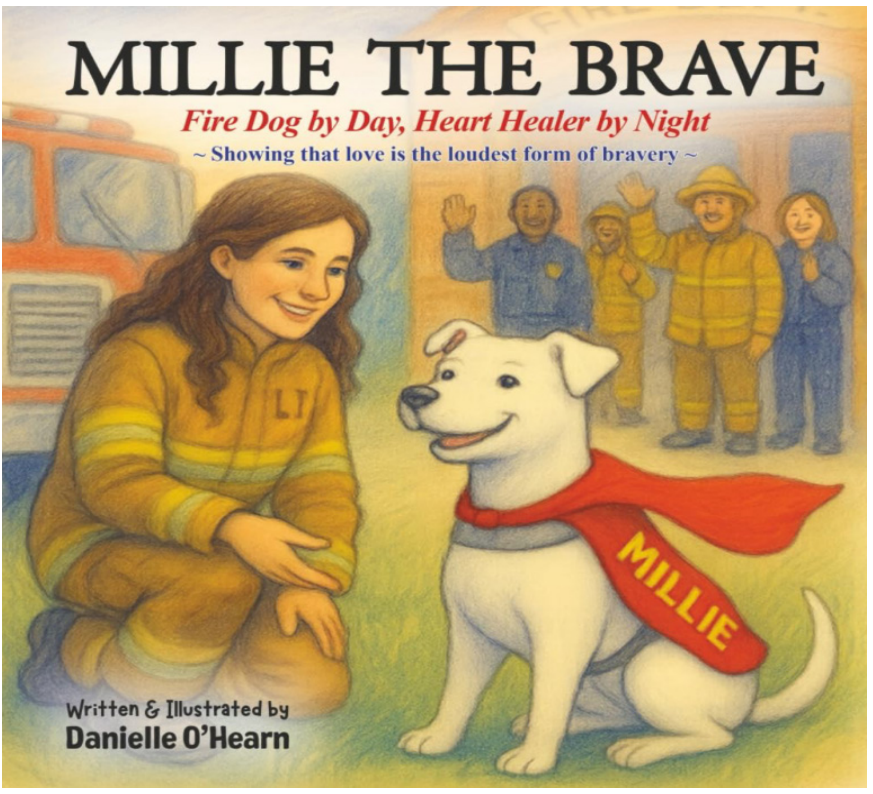

Who is their software engineer and what is their salary? Luckily, it was cancelled out. One of their staff sent me a cancellation immediately. At least someone in city hall is doing their job.

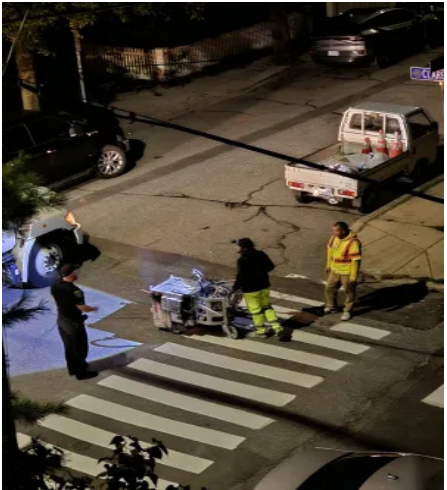
SPD showed up after I called to report the loud noise created by whoever this was since I could not identify the trucks.

Somerville to Host Public Forums on State’s Draft Cannabis Social Consumption Licenses



Mayor Ballantyne & Economic Development Office Invite Businesses & Community Members to Discuss City’s Approach to Coming New Regulations

SOMERVILLE— The Massachusetts Cannabis Control Commission (CCC) recently drafted three types of licenses

allowing for the “social consumption” of cannabis by adults 21 and older in

approved venues, similar to those allowing for alcohol consumption. Once these regulations are finalized, communities will be able to choose whether they opt into the new rules.

In the coming months, the City will be reviewing the CCC’s regulations and is proactively seeking public feedback to help shape Somerville’s approach to cannabis social consumption. These licenses will create new opportunities for individuals and businesses to consume or serve cannabis in accordance with CCC regulations and guidelines. To inform Somerville’s approach, Mayor Katjana Ballantyne and the City’s Economic Development division invite local businesses and residents to

participate in upcoming forums to learn about and discuss options.

Somerville/Medford Remembering Shannon Mary Ward



Obituary
Shannon Mary Ward had a generous spirit, a love of learning, and a life that took her across the globe. Shannon was born in Madison, Wisconsin, on May 8, 1990, and raised in Sudbury, Massachusetts. She paired her love of music, art, and adventure with a passion for learning that grew into a deep engagement with languages, cultures, and people far beyond her hometown.

Growing up, Shannon’s passions were playing the cello, celebrating Halloween, watching and reen-

acting Disney movies, and playing with the family dog, Ruffy. She loved roller coasters, haunted houses, and inner-tubing. She excelled at school, and during the summers, she vacationed visiting family in Canada and Minnesota, hiking in Algonquin Park, and waterskiing on Lake Okanagan.

In high school, Shannon discovered a study-abroad program in India and spent her final semester living in cities across North and South India. That six-month experience changed the trajectory of her life. It was there that she fell in love with language learning—especially Tibetan language, culture, and people.

Shannon went on to earn a bachelor’s degree in anthropology from Wellesley College, and later a PhD in Linguistic Anthropology at New York University, mentored by Bambi Schieffelin. As part of her doctoral research, she spent extended periods living in Dharamsala, India; Kathmandu, Nepal; and Xining, China,

where she became part of the Tibetan communities she studied, forming lasting friendships and connections that enriched both her life and her research. Her research centered on bilingual children whose first language is Amdo Tibetan and culminated not only in her dissertation but also in her book, *Amdo Lullaby*, published by the University of Toronto Press in November 2024.

Immediately after graduating with her PhD, Shannon earned a tenure-track faculty position at the University of British Columbia Okanagan as an Assistant Professor of Anthropology. She loved teaching and mentoring students, especially international students who she supported in navigating their academic journeys and, in many cases, helped transition to new lives in Canada. Shannon also collaborated widely with colleagues around the world. She presented at conferences from Norway to Hawaii, and remained active in the American Anthropological Association, the

Canadian Anthropological Society, and the Society for Linguistic Anthropology. In Vancouver, she worked closely with the Tibetan community, deepening her research while cherishing the generosity and friendships she encountered there.

Beyond her academic life, Shannon had a quiet, creative side. She loved coffee shops, yoga, art, music, and the companionship of her two beloved cats, Evie and MeiMei. She will be remembered as a brilliant scholar, a generous mentor, a treasured friend, and a thoughtful human with a precious inner beauty.

Shannon achieved impressive professional and personal accomplishments while privately overcoming lifelong challenges with anxiety and depression. Her suffering grew overwhelming in the last six months. She passed away in Cambridge, Massachusetts on September 9, 2025.


Shannon will be deeply missed

by all who loved her. Especially her mother, Kim, her brother, Brandon, sister-in-law, Cathy, niece, Alice, nephew, Sam, aunts, uncles and cousins in Canada and the US.

A Celebration of Life will be held on Sunday, November 2 at 1:30pm at Saint Matthews United Methodist Church in Acton, Massachusetts. The service will have a livestream and be recorded. Donations may be made to The Tibetan Culture Society of BC, the University of British Columbia Okanagan, or your local pet shelter.

Greater transparency, enhanced public engagement, strengthened City Council oversight, a change in Mayor term length, and a pathway to ranked choice voting, as well as other modernizations now await approval by voters on November ballot

SOMERVILLE – Massachusetts Governor Maura Healey signed the proposed new City of Somerville Charter today, Sept. 9, and now the joint efforts of Mayor Katjana Ballantyne, the City Council, and the Charter Review Committee to update the charter are ready for voter approval. Two November 4, 2025, ballot questions will allow voters to decide whether to accept the charter and whether to extend the

Mayoral term.

If the charter is approved by voters, a range of updates would go into effect immediately including that bodies will be created to develop plans to implement ranked choice voting (which allows voters to rank multiple candidates rather than vote for only one) and to explore public financing of election campaigns. If the separate Mayoral term question laid out in the charter passes, the Somerville Mayor would serve a term of 4 years rather than the current 2-year term, and the change would go into effect no earlier than the 2028 term. The approved charter proposal can be read at sommervillema.gov/charter-review.

Key changes in the updated charter include (but are not limited to):

- Improving readability by removing Latin and updating outdated 1899 verbiage
- Bringing charter requirements in line with modern practices
- Increasing the oversight power of the City Council in the areas of confirmation of department heads and board and commission members, annual audit reporting, allowing for the provision of Council legal counsel, and explicit authority to hire Council staff.
- Adjusting and codifying budget timelines

and processes including requiring: a community budget hearing before budget preparation; an annual joint meeting of the City Council and School Committee, called by the Mayor, to review the financial condition of the city; and, a public hearing on the proposed budget before the City Council takes action. Requiring a review of the charter, the code of ordinances, and the city's boards and commissions every 10 years.

Many existing charter components remain unchanged, including retaining: The current form of government, with the Mayor serving as the chief executive officer, with the power to appoint department heads, enforce ordinances, and manage the day-to-day operations of the city, and the City Council serving as the legislative branch. The composition of the City Council and the School Committee, and the Mayor and City Council President serving by virtue of their offices. A 2-year term of office for all elected officials. "These charter reforms represent a major step forward for Somerville – increasing transparency, strengthening democracy, and ensuring the shape of our city government reflects our community values," said Mayor Ballantyne. "I'm grateful to

Sen. Jehlen, Rep. Barber, and our entire legislative delegation for shepherding this through the Legislature, Ward 1 Councilor Matt McLaughlin for championing charter reform throughout, and Governor Healey for finalizing this decades-long effort. This achievement reflects the power of inclusive leadership and community voices working together to shape Somerville's future."

"This charter now reflects the times we live in and gives us a modern framework," stated Councilor Matt McLaughlin. "This was a deeply democratic and inclusive process involving residents volunteering extensively and gathering input from thousands to draft this charter. It provides crucial improvements, from clear, modern language to addressing the balance of power between the Mayor and City Council in areas like the budget and appointments. Ultimately, this approved charter is light years better."

The majority of changes are the direct outcome of recommendations by the Charter Review Committee, composed of residents and elected officials. The Council and City then collaborated to transform those proposals into new charter language.

Bringing an 1899 charter into the 21st century

The City's charter was initially established in 1871, the same year Somerville was incorporated as a City. Since a more substantial update in 1899, it has undergone only targeted revisions. More recently charter review was launched in 2008. A 2018 City Council initiative modernized the name "Board of Aldermen" to "City Council." In 2019, then Councilor Ballantyne initiated an update to shift oversight of the Committee Clerks from the Administration to the City Council to streamline management and improve workflows. In 2021, then Councilor Ballantyne also led the Council in submitting a special act to amend the charter to use gender-neutral language.

Full charter review began in 2020, when former Mayor Joe Curtatone and then City Council President Matt McLaughlin (now Ward 1 Councilor) jointly launched the latest comprehensive review. The Charter Review Committee established as a result met for 16 months and issued a range of recommendations in August 2022. The Ballantyne Administration and City Council then jointly updated the charter to ensure it met legal standards. Mayor Ballantyne Introducing Home Rule Petition to Expand Procurement Opportunities for Disadvantaged Businesses



SOMERVILLE– Today, Mayor Katjana Ballantyne will introduce a Home Rule Petition to City Council that seeks to make it easier for certified disadvantaged businesses to compete for

City contracts, advancing Somerville’s commitment to equity and economic inclusion. This petition builds on a recommendation of the disparity study conducted in partnership with the City of Brookline and Griffin & Strong, P.C.

“This proposal is about equity as much as it is about efficiency,” said Mayor Ballantyne. “When small, diverse, and disadvantaged businesses have a fair chance to compete for City work, our local

economy grows stronger, our communities thrive, and City government better reflects the values of inclusion that define Somerville.”

The petition would raise the thresholds under Massachusetts General Law Chapter 30B specifically for City contracts with certified disadvantaged, diverse, or small and local business enterprises. Eligible businesses are those formally certified by the Commonwealth’s Supplier

Diversity Office, by the City of Boston, or by the City of Somerville.

Under the proposed legislation: The City could use sound business practices for contracts up to \$20,000 (up from the current \$10,000). The City could request at least three written quotes for contracts up to \$250,000 (up from the current \$50,000).

By raising these thresh-

olds, the petition simplifies the bidding and quote process, reducing barriers for smaller and disadvantaged businesses and expanding opportunities for underrepresented vendors to partner with the City.

If approved by the City Council, the Home Rule Petition will move to the State Legislature for consideration.

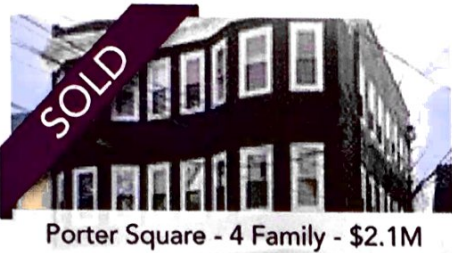

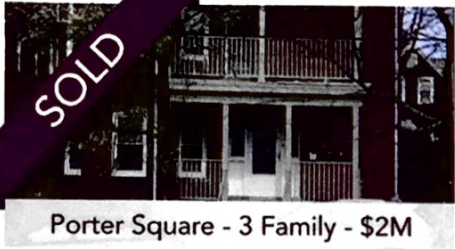

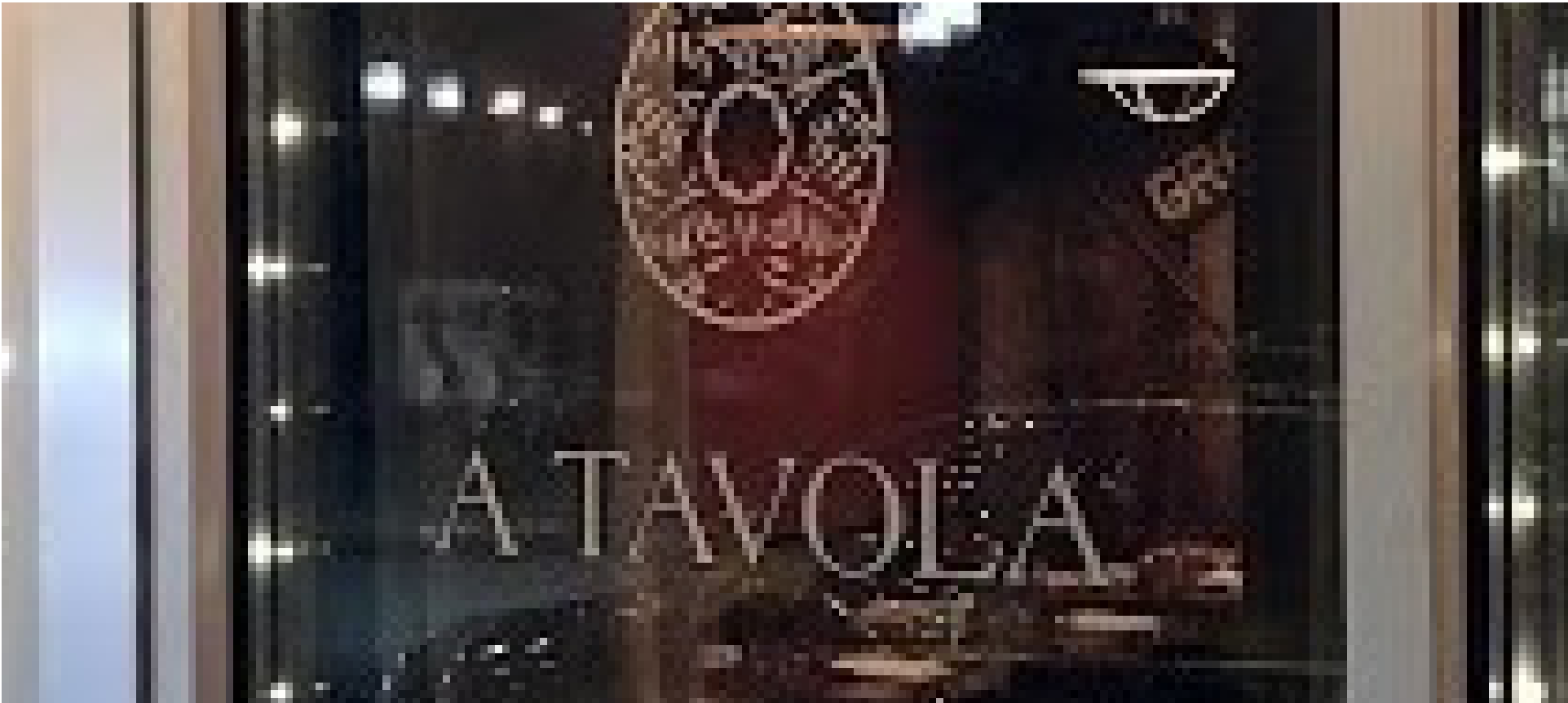
